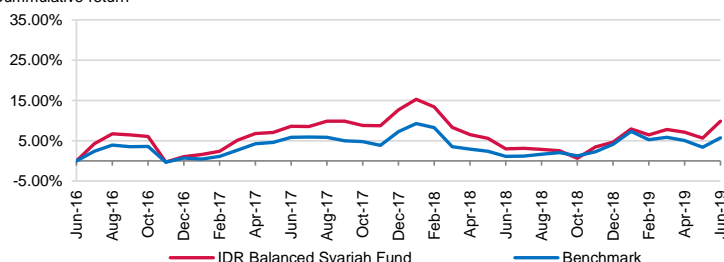

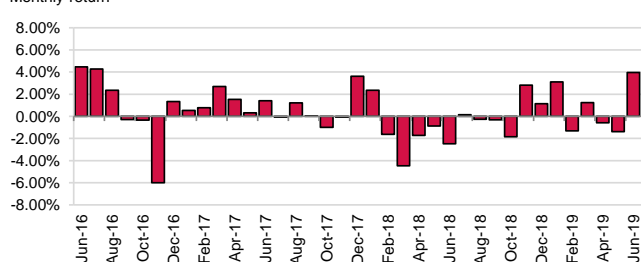
LAST 3 YEARS CUMULATIVE RETURN

Cummulative return

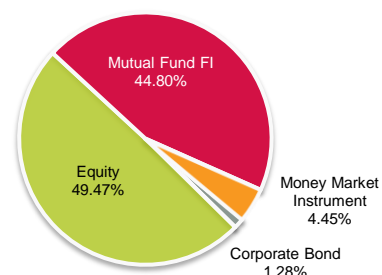


LAST 3 YEARS MONTHLY RETURN

FUND MANAGER COMMENTARY

In June 2019, IDR Balanced Syariah Fund booked performance of +3.96%. Equity market went up by 3.3% with Communication Services sector as the largest positive contributor. The positive factors for equity market was driven by hint on Fed intention to cut rate, positive sentiment after Trump-Xi meeting at G20, and BI decision to lower the reserve requirement ratio as well as smooth process of Constitutional Court decision making. Meanwhile, Bloomberg Indonesia Local Sovereign Index (BINDO) went up +4% on monthly basis, with foreign inflow of IDR 39 trillion in June 2019. Global positive sentiment was coming from higher expectation of Fed rate cut in second half 2019 and lower trade war tension between US and China. On domestic side, combination of strengthening IDR, diminishing political tension and lower benchmark interest rate expectation created positive sentiment for Indonesia bond market.
