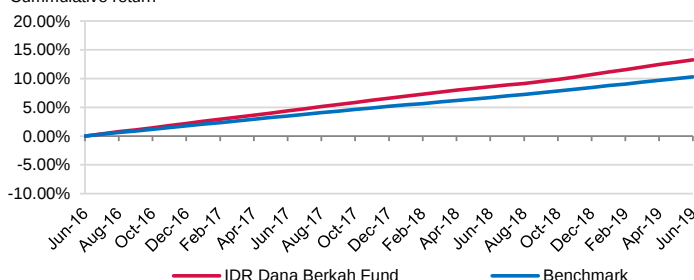

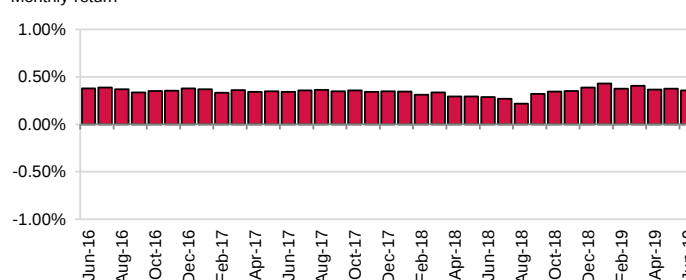
LAST 3 YEARS CUMULATIVE RETURN

FUND MANAGER COMMENTARY

Inflation in May 2019 rose further to 3.32% YoY (0.68% MoM), compared to previous month's figure of 2.83% YoY (0.44% MoM). The acceleration was led by food inflation. Meanwhile, BI kept its 7-Days Reverse Repo policy rate at 6.0% for 7th consecutive month, but cut banks' reserve requirement ratio by 50bps. The central bank was keen to wait for more clarity post G20 and US Fed policy rate. At the same time, sharia principle banks distributed their mudharabah return at the range of 7.00%-8.50% per annum and IDR Dana Berkah Fund booked return of +0.36% in June 2019.
