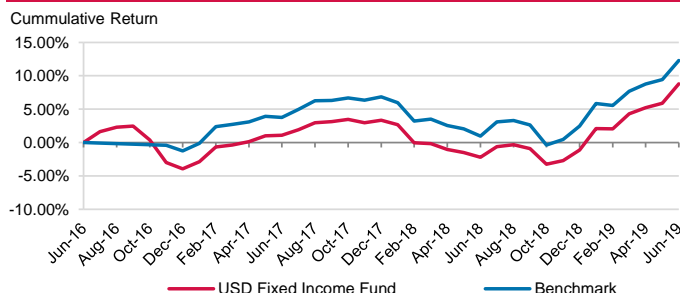

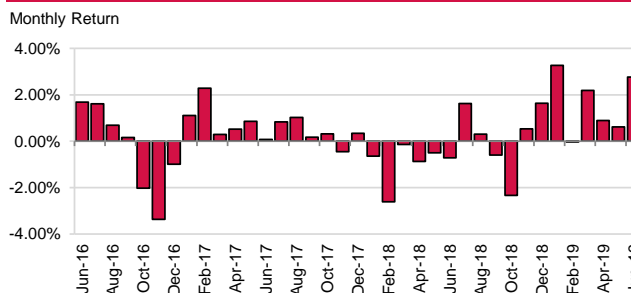

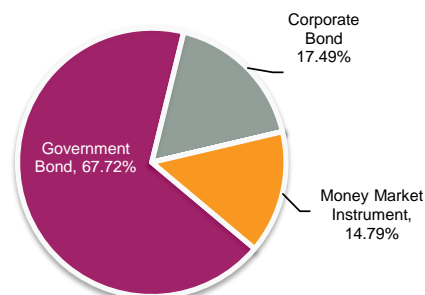
LAST 3 YEARS CUMULATIVE RETURN

FUND MANAGER COMMENTARY

Indonesia sovereign and quasi sovereign bonds strengthened in line with the movement of US Treasury bonds, which continued to rally on the back of rate cuts expectation from the Federal Reserve and trade war tension eased between US and China as President Donald Trump holds off additional USD300 billion import tariff and allows US companies to continue doing some business with Huawei. A dovish tilt to monetary policy globally would give comfort to investors in search of higher yield in emerging market including Indonesia. The USD Fixed Income Fund recorded performance of +2.76% in June 2019.
