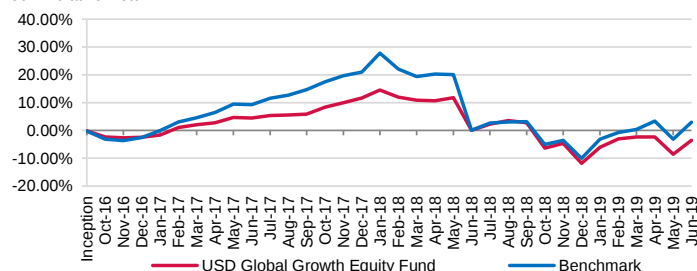

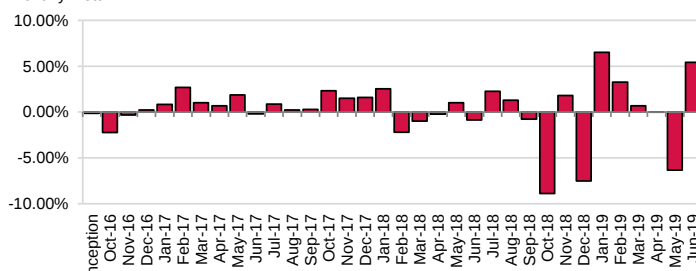
LAST 3 YEARS CUMULATIVE RETURN

FUND MANAGER COMMENTARY

In June 2019, USD Global Growth Opp. Equity Fund booked performance of +5.41% mom, in line with MSCI World performance of 6.5% and MSCI Asia ex-Japan performance of 6.1%. Global market rebounded in last month, driven by hint on Fed intention to cut rate in the near term with current market expectation of 2-3x Fed rate cut up until the end of the year. Added into the positive sentiment was Trump positive commentary after the meeting with Xi at G20 event that resulted in resuming trade negotiations. Going forward, global equities will continue to depend on economic development, currency's stability, and global risks' dynamics.
