






### ASSET ALLOCATION

#### FUND MANAGER COMMENTARY

In April 2022, IDR Prime Equity Fund booked performance of 5.04% mom, above the benchmark performance. By sector inside JCI, energy was the largest positive contributor(+1% mom), while consumer discretionary was the largest negative contributor(-1.1% mom). In last month, global market posted a significant correction driven by increasingly hawkish Fed, intensifying lockdown in China, and continuing uncertainty from Russia-Ukraine war. In the other hand, domestic market posted positive return with IDR40trn net foreign inflow, driven by Indonesia unique position as net commodity exporter. Going forward, Indonesia Equity market will continue to depend on the development of global and domestic factors such as development on global inflationary pressure and subsequent policy reaction, global economic growth, and geopolitic situation.
