

FUND MANAGER COMMENTARY

In March 2022, IDR CII Equity Fund booked positive return of +1.97% mom, outperforming its benchmark. In March 2022, China equity market corrected in the early part of month but rebounded in the later part of the month amid continuation of Russia-Ukraine war, 25bps Fed rate hike, and Shanghai lockdown. However, India and Indonesia equity markets rallied driven by net foreign inflows and domestic economic reopening. Going forward, China, India & Indonesia equity markets movement could continue to be influenced by the development of global and domestic factors such as development & global policy reactions on Ukraine-Russia war, and also by domestic fiscal and macro-economic policies especially in containing the currently rising inflationary pressure while boosting or preserving growth.
