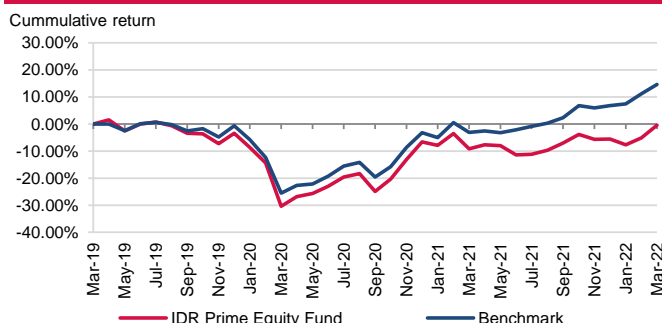

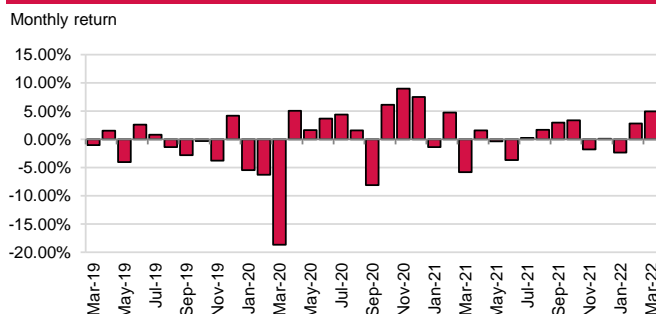

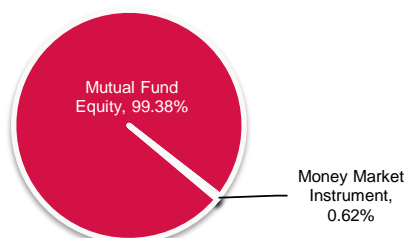
LAST 3 YEARS CUMULATIVE RETURN

FUND MANAGER COMMENTARY

In March 2022, IDR Prime Equity Fund booked performance of +4.97% mom, above the benchmark performance. By sector inside JCI, materials was the largest positive contributor (1% mom), while information technology was the least positive contributor (0% mom). In last month, global market generally posted positive performance, except for China market, with correction in the early part of month and rebound in the later part of the month amid continuation of Russia-Ukraine war, 25 bps rate hike from the Fed, and Shanghai lockdown. Domestic market also rallied driven by IDR8.5tn net foreign inflow, supported by Indonesia position as net commodity exporter, strong trade data, and economic reopening. Going forward, Indonesia Equity market will continue to depend on the development of global and domestic factors such as development on Ukraine-Russia war as well as the policy reactions surrounding the war, fiscal and macro policy, as well as Covid-19 development.
