


LAST 3 YEARS CUMULATIVE RETURN

FUND MANAGER COMMENTARY

IDR Prime Fixed Income Fund generated +1.78% in May 2024, and the 10-year government bond yield went down by -32 bps to 6.92%. Market sentiment came from stable IDR and stronger Indonesia's economy. The country's GDP growth in 1Q 2024 reached 5.11% YoY, surpassing both the previous quarter's growth of 5.04% YoY and the consensus expectation. Bank Indonesia maintained its interest rates at 6.25%, in line with the prostability monetary stance.
